You shall.....

- 1) Be a financial member of the Mini Car Club NSW. (provide membership card)
- 2) Provide a Safety Inspection Certificate (Pink Slip) to the MCC Plate Examiner and provide the number on the CPM02 and 1835 form.
- 3) Provide Engineering approval for required modifications for viewing.
- 4) Have the car inspected and passed by a Mini Car Club Eligibility examiner.
- 5) Have current insurance (minimum 3<sup>rd</sup> party/property) and provide details on this form.
- 6) Complete the eligibility checklist (CPM02) sheet.
- 7) Complete the 1835 form (provided with your renewal from the RMS)
- 8) Complete the log sheet (CP03) form showing attendance at a minimum 3 MCC events in the previous year.
- 9) Send all 3 sheets (CPM02, CP03 and 1835 form **INCLUDING A STAMPED SELF ADDRESSED ENVELOPE** to the Club Plate Registrar, who will stamp and return the 1835 form for you to provide to the ACMC with the registration renewal.

( remember to take your pink slip and current Club membership card to the RMS office)

Failure to comply with these Club Plate rules may result in your removal from the scheme. It is your responsibility to comply, as not doing so may render you and the Mini Car Club liable to litigation should an accident occur and the MCC Club Plate registration be found to not be in accordance with the above requirements.
